AUDIT SUMMARY

Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Town management in a letter dated December 15, 2014, related to internal controls over financial operations. We appreciate the Town's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Town of Coupeville from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Payroll/personnel
- Credit card controls and payment
- Software access levels/new system implementation

STATUS OF PRIOR AUDIT FINDINGS

The status of findings contained in the prior years' audit reports of the Town of Coupeville is provided below:

1. The Town paid its employees extra compensation which is not allowable per the Washington State Constitution.

Report No. 1009833, dated March 29, 2013

Background

During 2011 and 2012, the Town approved budget amendments to authorize one-time payments of \$1,200 per full-time employee, as retroactive pay.

Status

The condition reported in the 2012 audit has been resolved. There were no retroactive or additional compensation payments for employees in 2013 or 2014 to date.

INFORMATION ABOUT THE TOWN

The Town of Coupeville encompasses approximately 1.1 square miles in Island County and has a population of approximately 1,865 citizens. The Town provides services including administration, public safety, planning, public works, utilities and parks and recreation. In addition, the Town has a franchise agreement for solid waste collection and cable service. Central Whidbey Fire District provides fire protection service for the Town.

An elected, five-member Council and an independently elected Mayor govern the Town. For fiscal years 2012 and 2013, the Town had budgeted expenditures of \$5,088,589 and \$6,118,461, respectively.
