ORDINANCE NO. 355C

1 An Ordinance of the Town of Coupeville, Washington, amending  
2 Ordinance No. 355B of the Town.

3  
4 BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF COUPEVILLE,  
5 WASHINGTON, as follows:

6 SECTION 1: PART C, GARBAGE: Section 1. GARBAGE RATES: shall be  
7 amended to read as follows:

8 "SECTION 1: GARBAGE RATES:

9 The monthly rates for garbage collection charged by the Town of  
10 Coupeville are as follows:

11 1. The monthly rates for residential garbage collection shall be a  
12 minimum of six dollars and seventy-five cents (\$6.75). This charge entitles a  
13 householder to a pick-up of two (2) cans, once a week. The householder shall  
14 be assessed a charge of seventy-five cents (\$.75) per can for each additional  
15 can over two (2) cans. In addition, if the garbage collector has to ascend or  
16 descend more than four (4) steps in carrying the garbage can to the collection  
17 truck, an additional charge of one dollar and ninety-five cents (\$1.95) per can  
18 per delivery will be made.

19 The monthly rate for commercial garbage collection shall be a  
20 minimum of nine dollars (\$9.00). The said charge entitles a commercial  
21 establishment to a pick-up of two (2) cans once a week, or in the alternative  
22 one (1) can twice a week. The commercial establishment shall be assessed and  
23 charged an additional seventy-five cents (\$.75) for each additional can per  
24 pick-up. If the garbage collector determines that the commercial garbage is not  
25 properly containerized, the Town may assess and charge an alternate rate for  
26 commercial garbage pick-up in the amount of Twenty-one dollars and sixty cents  
27 (\$21.60) per hour for the time necessary to pick-up the said commercial garbage."

28 SECTION 2: This Ordinance shall be in full force and effect after  
29 January 1, 1986 and proper posting and publication by the Town of Coupeville.
