

ORDINANCE NO. 381B

An Ordinance amending the regulations relating to automobile parking requirements and amending Ordinance No. 381 dated October 22, 1984.

BE IT ORDAINED by the Town Council of the Town of Coupeville, Washington, as follows:

That this Ordinance is adopted in order to promote and protect public health, safety and general welfare.

SECTION 1: The following sections shall be revised as specified below:

SECTION 10.30.050 (D) (5): Change to read:

"Off-street parking and loading space required, and shall be provided as required in Section 10.30.085, except in the Historic Front Street area bounded by Coveland Street on the south, Alexander Street on the west, Main Street on the east and extending into Penn Cove to include the Coupeville Wharf."

SECTION 10.30.055 (D) (5): Change to read:

"Off-street parking and loading space required and shall be provided as required in Section 10.30.085, except in the Historic Front Street area bounded by Coveland Street on the south, Alexander Street on the west, Main Street on the east and extending into Penn Cove to include the Coupeville Wharf."

SECTION 10.30.056 (D) (5): Change to read:

"Off-street parking and loading space required, and shall be provided as required in Section 10.30.085, except in the Historic Front Street area bounded by Coveland Street on the south, Alexander Street on the west, Main Street on the east and extending into Penn Cove to include the Coupeville Wharf."

SECTION 10.30.085 - OFF-STREET PARKING AND LOADING REQUIREMENTS:

A) Intend and Purpose

Revise to read:

"It is the intent of these regulations to provide for off-street parking

1 for employees, customers, and residents of structures and uses in the Town
2 of Coupeville. This will relieve on-street congestion and provide safe
3 and convenient access to private properties."

4 B) Off-Street Parking Spaces to be Provided

5 First paragraph should be numbered "1)".

6 Add:

7 "2. In the Historic Front Street area bounded by Coveland on the south,
8 Alexander Street on the west, Main Street on the east, and extending into
9 Penn Cove to include the Coupeville Wharf, the minimum required parking
10 standards contained in this section shall not apply."

11 SECTION 10.30.085 (D) (17) BEAUTY AND BARBER SHOPS: Change to:

12 "1 parking space per 125 square feet of gross floor area."

13 SECTION 2: Coupeville Ordinance No. 381 is hereby amended.

14 SECTION 3: This Ordinance shall be in full force and effect upon
15 the passage by the Town Council and proper posting according to law.
