NOW, THEREFORE, BE IT ORDAINED, by the Council of the Town of Coupeville, Washington as follows:

SECTION 1: That the zoning classification of the following described property be changed from Commercial District (C-1) to Municipal Building District (MB):

That portion of Block 10, Plat of Coupeville, described as follows: Beginning 343' South and 33' East of the NW Corner of the T. Coupe DLC, thence South 86', thence East 120.81', thence North 54° 30' West a distance of 148.30' to the point of beginning.

SECTION 2: That the zoning classification of the following described property be changed from Commercial District (C-1) to Municipal Building District (MB):

That portion of Sec. 33. Twp 32 N, R. 1E described as follows: Beginning at a point 181.8' South of the SW corner of Block 40 of the Plat of Coupeville, thence East 326 feet, thence South 173.5', thence West 326', thence North 173.5' to the point of beginning.

SECTION 3: That the official zoning map of the Town shall be amended to reflect these changes.

SECTION 4: This ordinance shall be in full force and effect upon posting and recording with the Auditor of Island County, Washington.


